Dr. Dominicis is the first Dental Board of California member who obtained his dental license in California by way of the Bench or RT Examination. He is a general dentist in private practice in the City of Downey, California since 1993. Dr. Dominicis has served in the following capacity at the Dental Board: as the Secretary of the Board, Chair of the Appeals Committee, Chair of the RDAEF Examination Committee, Vice Chair of the RDA Examination Committee, Vice-Chair of the Licensing, Certification and Permits Committee, Member of the Legislative and Regulatory Committee and of the Enforcement Committee among others. Dr. Dominicis is a Dental Examiner and Registered Dental Hygienist Examiner for the Western Regional Examination Board or WREB. Dr. Dominicis is Past President of Los Angeles Dental Society, Past President of the Latin American Dental Association. Dr. Dominicis has also served in various Councils in the California Dental Association such as Council on Legislative Affairs, Council on Community Health and in the Reference Committee for the House of Delegates.
