WOULD YOU BUY A DENTAL PRACTICE WITHOUT SEEING THE FINANCIAL INFORMATION? OF COURSE NOT!

Some dental practice brokers have begun to require a \$10,000 deposit and a signed offer prior to releasing ANY financial information on the practice to the buyer. This is completely unethical. How can a buyer make an informed decision about a dental practice without the financial information? It is equivalent to trying to buy a house without actually seeing the house.

The brokers that engage in this practice often have a high "fall out" rate or offers that never come full circle to consummation of the deal, because more often than not, the actual financial information, when ultimately presented, is not exactly what the buyer expected or what the banks could approve for financing. Admittedly, this sales technique postpones the initial discussion about the practice profitability and financial viability until a buyer has lost money on escrow fees, attorney's fees, and possibly consultant's fee, which increases the buyer's financial loss/commitment, but it does not make that discussion disappear nor does it benefit the seller by getting the deal done. Everyone loses.

As a buyer, you have a right to full disclosure of the practice financial information so that you can make an informed decision. This does not mean that you will not need to sign a confidentiality agreement or that you would have access to the supporting information such as bank statements, general ledgers, payroll tax returns, etc. until an acceptable offer has been made as this information is corroborating material, but without the profit and loss statements and tax returns how can you even make an offer?
