



# ASK THE BROKER

# I have too much debt. I can't buy a practice now!

TIMOTHY GIROUX DDS/BROKER

This thought seems to be prevalent now in the dental transitions community. Since the economic crash of 2009, we saw a seller's market as many aging baby-boomers that had planned on retiring decided to work a few more years to make up for their lost portfolios. Now that we are starting to see more practices coming to the market, we are not seeing as many interested buyers as we'd expect, especially considering the additional dental schools that have been built in the past 10 years. I attribute this slowdown in buyer activity to three issues:

- 1. Since Jim Pride passed away in 2004, there has been no voice to replace his message of "Go out to the small towns and knock it out of the park." He was a big component of making it big in smaller towns where the overhead costs and cost of living are much lower than in the big cities. I believe his line was "Work 4 days in the country and fly your plane into the city on the weekends and take your city classmates out for dinner!". Our practices located in the desirable parts of the Bay area are still getting record offers, more than we have seen in the past. However, practices in the Central Valley from Fresno to Redding are seeing less activity than ever before, and even the Sacramento area is slower.
- 2. Corporate dentistry is attractive to new graduates. I understand as I worked for corporate for 2 years after my graduation. I believe I honed my dental skills much quicker than some of my classmates because I was exposed to more dentistry in that time than they were. However, as my last article on corporate dentistry\* pointed out, corporate dentistry exists to make a profit from the hands of the dentist. This brings us to our third reason there are less buyers out there.
- 3. DEBT. The current new graduate has an estimated \$350,000 of combined school debt. That number rises every year as college, dental school costs and the cost of living goes up. I believe that many of the graduates are afraid of entering into more debt through the purchase of a practice.

What these students don't realize is that purchasing a successful practice is the best way to pay off this debt. Their best path initially is to get an associate or GPR position to hone their skills and speed. Once this is accomplished in a couple of years or so, they need to realize that they will take home on average 50 to 75 percent more as an owner performing the same amount of dentistry. This "extra profit" is why corporate dentistry exists, and wouldn't it be better for the young dentist to use that profit as a business owner to pay off their debt?
