

DISCLOSURE REQUIREMENTS AND NEW DEVELOPMENTS

The majority of the case law pertaining to the disclosure requirements by dental practice sellers and brokers is derived from real estate transactions. The more obvious of these requirements is the disclosure of defects or negative facts. In one case a seller's failure to disclose negative issues that would have a foreseeable depressing affect on the future value of the property created liability and in another case it was found that sellers had an absolute duty to disclose prior damage that had been repaired. Brokers have no duty to inspect commercial property, no duty to explain the implications of a disclosed fact, no duty to disclose speculative statements and Sellers and brokers alike have no duty to explain the legal ramifications of disclosed facts to buyers. There is a duty for both to disclose material facts to a buyer.

Court cases in California involving dental practice sales have consistently found that seller's have a duty to disclose material defects associated with the practice to buyers and that brokers cannot fail to disclose material defects of which they have actual knowledge. What types of material facts would a seller of a dental practice be required to disclose? The pending loss of a substantial group of patients due to a loss of an insurance plan, loss of or discontinuation of an established marketing plan, the exclusion of a piece of equipment that contributes to the income or reduces the overhead of the practice, or the departure of a long time associate that has relocated within the community who is now soliciting patients are examples of relevant disclosures. With dental practices, the types of disclosures that have been found to be relevant have more to do with the income aspect of the business than the physical defects associated with residential real estate litigation. In short, if, as a seller, you are aware of a fact or an event that has occurred that has or, with reasonable certainty, will have a negative effect on the patient flow or future income of the practice, disclose it.

Buyers and sellers should be aware of the fact that **some dental practice brokers habitually fail to make such disclosures.** The failure of the broker to disclose a known material fact creates liability for the broker, but does not relieve the seller from the seller's absolute duty to also disclose all information to the Buyer. For all such material disclosures, keep copies of the information that has been provided to the Buyer and memorialize the disclosures in the sale agreement. This substantially reduces the risk of post-sale litigation.
