Dr. Marus's morning course will demonstrate a simplified method of restoring the fractured maxillary anterior central incisor with composite resin creating an undetectable restoration. Learn how to: quickly treat the classic fractured anterior tooth with a simplified composite layering technique • create facial anatomy and texture • prevent grayness in the restoration Dr. Mills will address dental trauma, reviewing this important and often overlooked area of dentistry.
