THE VERY IMPORTANT ASSIGNMENT AND SUBLEASE PROVISION

There is a little provision in every dental office lease that dentists often overlook. The assignment and sublease provision of a dental office lease becomes important during the sale of a practice or the sublease of space because it often provides a landlord with vast control over the assignment or sublease. A landlord can exercise considerable control by withholding consent for the assignment or sublease and by keeping the original tenant liable on the lease. As a result, the initial lease negotiations are extremely important for an event that will likely take place years or decades in the future. During the initial lease negotiations, a dentist can negotiate to have the landlord not be able to unreasonably withhold consent for the assignment of the lease or to remove the dentist from lease obligations upon an assignment or sublease. A dentist selling his/her practice must ensure that providing the buyer with the right to use his/her name does not create any additional liability for the selling dentist. Therefore, the selling dentist must make certain that the purchase and sale agreement provides a provision in which the buyer is responsible for the maintenance of insurance that protects the selling dentist for the use of his/her name. ASK THE BROKER

Question:

What can I do as a buyer to help me in my negotiations with a Seller?

Timothy G. Giroux DDS/Broker

Last Month, we talked about some of the obvious things you can do to ease your negotiations with a Seller. This included putting your best foot forward with the Seller the moment you first meet. If you convince the Seller that you will preserve the patient and staff relationships, the Seller will be more comfortable selling the practice to you. We also pointed out that it may not be in your best interest to share any of your negative thoughts about the practice with the Seller directly. Share those concerns with the Broker at a later date.

Notwithstanding the above, many Sellers will state that it is not all about the money when choosing their successor. While this may be true in some cases, my experience shows that the highest bidder usually wins the prize. However, many Buyers do not step back and look at the situation from the Seller's viewpoint.

Say you were selling a house and had two interested Buyers. The first Buyer thoroughly looked at the house with all its flaws and was genuinely excited about the house and looked beyond the leaks in the roof. The second Buyer looked at all the flaws and immediately started pointing them all out and what it would cost to fix them all.

Let's say the second Buyer makes the highest offer. Who do you think the Seller would prefer to work with? The Seller will naturally negotiate with the more cooperative party to have them meet or beat the higher offer. In my experience, the more cooperative Buyer will usually increase their offer.

What just happened? The market ultimately determined the price as the serious Buyers will meet the market value, and the Seller will pick the Buyer they perceive will be easier to deal with. While this scenario may not happen outside the big cities, the Buyer who puts their best foot forward from the start will usually enjoy a smoother transition and a more successful future in the practice.

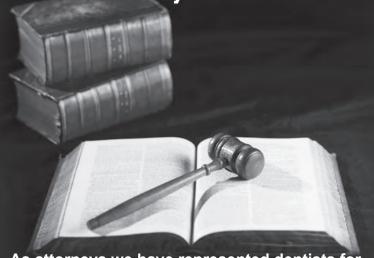

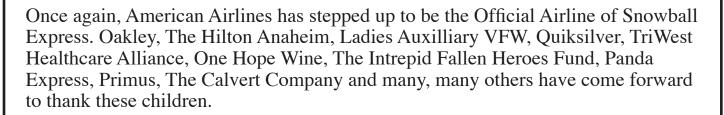

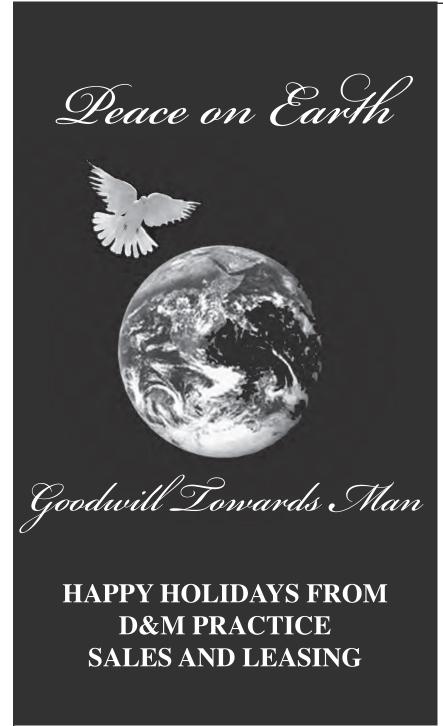
